UPDATE: Trop Gun Shop Burglary Arrests

Det. Frank H Ember Jr of the Northwest Regional Police has filed charges on 3 Persons for the Burglary and Theft that occurred at the Trop Gun Shop on May 29th, 2016

The Northwest Regional Police in coordination with the ATF(Alcohol-Tobacco-Firearms), Williamsport City Police, Harford County MD Sheriff's Department and Have De Grace MD Police has resulted in charges for three subjects with Burglary, Theft, Criminal Conspiracy, and Criminal Mischief for the May 29th, 2016 Burglary of the Trop Gun Shop at 910 N Hanover St. Elizabethtown.

Parrish "Prince" Valentine is in custody in the Lycoming County Prison since June 3rd,2016 for the possession of one of the stolen handguns from the Trop Gun Shop Burglary.

Lena L. Griffith is currently in custody in the Harford County Detention Center, MD since June 1st for unrelated charges.

Shawn "Magic" Prim has an active warrant for his arrest on these charges. He is believed to have at least one firearm in his possession.

All three of the subjects have significant ties to the Bloods & Crips Street gangs and the remaining stolen handguns are believed to be possessed by members of those Gangs.
